VOUCHER EXPERTS TO SPEAK AT SEPTEMBER LUNCHEON

“Hey, I don’t like the idea of public tax dollars being used for private school vouchers. But I’m retired, so it really doesn’t impact me, right?” **WRONG!**

Funding for the Ohio school voucher program, known as EdChoice, exploded to \$2 billion in the budget bill signed by the Governor last year. Voucher funds come from the same budget line-item that funds our public school systems. When vouchers were first enacted, a family of four earning \$75,000 or less a year qualified for full vouchers. Now, the income ceiling has been raised to \$135,000; vouchers for k-8 kids are roughly \$6,200 and \$8,500 for high school kids. Incredibly, families making more than \$135,000 qualify for vouchers albeit in reduced amounts.

Vouchers draw dollars away from schools, putting more pressure on taxpayers to approve levy requests. Vouchers draw students away from public schools, decreasing enrollment and reducing teacher numbers. The result is fewer members contributing to the retirement system, smaller district payrolls upon which employer contributions are based, and a much greater challenge to legislatively increasing the employer contribution percentage.

Vouchers Hurt Ohio is a coalition of public-school districts (including Akron and seven other Summit County districts) suing the state over the unconstitutional and harmful voucher program. The Ohio Coalition for Equity and Adequacy of School Funding is leading the litigation effort. Its Executive Director, William Phillis, led the Coalition’s 1990’s Supreme Court victory declaring Ohio’s method of funding its public schools unconstitutional.

Retirees do have a stake in the fate of the Vouchers Hurt Ohio lawsuit. To learn more about the lawsuit and what retirees may do to support the effort, we’ve invited three experts from one of our own districts (Woodridge Local) to speak with us at the September luncheon. N’ecole Ast is the current Woodridge Superintendent. She is a member of the Equity and Adequacy Coalition’s Steering Committee. Ms. Ast’s predecessor, Mr. Walter Davis, was instrumental in the district board’s decision to join the Vouchers Hurt Ohio lawsuit. Woodridge treasurer Tom Morehouse will talk about the impact of EdChoice on district budgets.

So yes, vouchers do impact you as an STRS retiree. We strongly urge you to join us for lunch on September 17 to learn more about this growing threat to public school funding in Ohio and how you can help the lawsuit succeed. *Bill Siegfert*

One of the primary reasons our SCRTA organization exists is to help our members navigate life more safely throughout their retirement. There has been much written about the scourge of scammers. A scammer is constantly developing new methods to target victims with the goal being to get one's personal information and/or money. This article highlights 3 current scams ... check cooking, voice printing, and the multistage grandparent scam ... along with some actions one can take.

CHECK COOKING This scam involves fraudsters taking photos of stolen checks and using digital tools to alter information such as the name and the amount. The fraudster easily manufactures dozens of checks and drops them into numerous drop accounts.

What to do! Consider using credit cards or online banking. If you still use paper checks, drop the mail off at the post office and always look for suspicious transactions.

VOICE PRINTING SCAM AI generated voice scams, also known as voice synthesis themes scams, use artificial technology to create lifelike imitations of real voices. Scammers use these voice replicas to impersonate relatives, friends, or even financial institutions in phone calls to deceive unsuspecting victims.

How can you be safe? To prevent your voice from being duplicated, don't answer the phone immediately. Be aware of answering calls from people not on your contact list since the call could be coming from a phone that has been stolen or had its SIM card cloned.

If you do answer the phone **1.** Verify the callers' identity; **2.** resist the urge or pressure to act immediately, especially when money is involved;

Legislative and Legal Updates

Quick Fix for WEP and GPO Unlikely, Even as Support Swells

The number of legislators co-sponsoring bills in the House and Senate concerning the Social Security Windfall Elimination Provision and the Government Pension Offset is growing steadily. Unfortunately, prospects for a final resolution during the 118th Congress (2023-2024) remain slim.

Two bills in the House have both been referred to the Ways and Means Committee. HR 82, the Social Security Fairness Act, calls for a total repeal of both provisions. The bill has a record 323 co-sponsors. HR 5342, the Equal Treatment of Public Servants Act, has 35 co-sponsors and proposes amending the formula under which federal benefits are reduced. On the Senate side, S. 597 was introduced in March of 2023 and like HR 82, is known as the Social Security Fairness Act and calls for the repeal of both WEP and GPO. The Senate bill has been referred to the Senate Committee on Finance.

Most supporters of the bills recognize that the price tag for resolving the unfairness of the current formula, whether done by total repeal or by changing the formula, is high. Many feel that no bill can pass as a stand-alone bill, and that changes must be made as part of a broader social security bill addressing all of the problems Social Security faces now and in the coming years. Passage of legislation of that magnitude is not seen as occurring in the current Congressional session.

Employer Contribution Increase

Lynn Hoover, STRS Acting Executive Director, spoke at our June luncheon meeting about the System's effort to place a bill before the General Assembly which would increase the employer payroll

contribution rate from the current 14% to 18% over an eight year period (.5%/year). Getting a bill introduced and passed requires at the very least a team effort by STRS staff, active members and retirees.

Legislators may not be anxious to pass any bill that would increase local school district costs, especially in an election year. As if that in itself doesn't present enough of a challenge, ORTA, the organization that purports to represent the interests of active and retired teachers, has made the task much more difficult by its never ending allegations of mismanagement by STRS staff and countless other baseless and inaccurate criticisms of the System. One of ORTA's latest gaffes appeared in their July Update. (Updates are not normally published in July, but "recent media reports" drove the Executive Committee—all three of them—to determine one was needed this year.) In typical "the world's against us" fashion, Robin Rayfield claimed that with the exception of the Toledo Blade, reporting across Ohio's major newspapers "on matters concerning STRS is slanted in favor of the STRS narrative." Inexplicably, ORTA's home page has a link to an editorial by the "neutral" Blade suggesting that any legislator "dumb enough" to increase employer contributions to STRS "deserves the harsh TV commercials and mailers that would come with their next campaign." The editorial further accused ORTA's "reform majority" of having "lost their nerve" by voting for the STRS bonus proposal after initially rejecting it. As an aside, among The Blade editorial staff is a writer who prior to moving to the Blade blistered ORTA for its involvement in the QED investment scam. His editorial, reported on previously in SCRTA newsletters, was titled "Time for the Full Truth from ORTA." ORTA's decision to provide the link to the editorial on its home page is truly enigmatic. While the piece satisfies ORTA's thirst for criticism of the Retirement System staff and "non-reform" Board members, it also attacks increasing the employer contribution rate (a goal which ORTA ostensibly supports), and some of the reform candidates ORTA

OUTSMART THE SCAM



Stop talking & hang up

Do not give out personal information. Do not make ANY payments — especially payments via cryptocurrency, prepaid gift cards, wire transfer, or by mailing cash.

Call a trusted source

Scammers can “spoof” phone numbers so calls appear to come from a trusted source. Dial the number that you know & ask them to verify the information.

Alert the authorities

Report Summit County government imposter scams to the Sheriff's Dispatch at 330-643-2181.

Social Security scams can be reported online at oig.ssa.gov or by calling 1-800-269-0271.

portrays as STRS saviors.

3. refuse to do wire transfers, cryptocurrency or gift cards.

How to quickly identify an AI voice scam.

You only briefly hear your loved one's voice; they can't answer simple questions; you are called from an unknown number; someone quickly takes over the call; you're told to pay a ransom by a cryptocurrency or gift cards.

MULTISTAGE GRANDPARENTS SCAM In the past, scammers would call victims and impersonate grandchildren in a crisis. They temporarily claimed that they had been arrested after a car accident and that they needed immediate funds from their grandparents for a lawyer or bail. Referred to as the grandparent's scam, the con typically sees fraudsters call seniors and claim to be their grandchild, saying they've been arrested and need money to pay for their bail. However, a new variation of the scam sees the imposters **text** victims rather than call them.

How to stay safe: If you get a call or text from an unfamiliar number from a family member claiming to be in trouble, don't panic. Instead, after you've finished talking and certainly before sending money, the **Federal Trade Commission (1-877-382-4357)** recommends that you **call or text** the person at his or her usual number and check to see whether the family member is in trouble. If they don't answer, contact other family members or friends. If you have any concern that the emergency could be real, the scammers plead with you to **keep the situation secret**, so you won't try to confirm it.

Finally, if you think you have been scammed,

hang up and call all financial institutions immediately.

You must notify your bank and credit card issuers as soon as possible regarding your credit cards and attempt to reverse the situation. Block the scammer, secure your account and call law enforcement. Remember, even if you end up with a scammer, it's not too late to prevent a bad situation from getting worse. **Stay safe! Stay alert!**
