

### Talent Leaving STRS in Wake of "Reform" **Board Members' Endless Complaints**

Media outlets have had a lot to write and talk about lately when it comes to our retirement system. One term appearing often in reports about the recent goings-on at STRS is "chaos."

Here's why. Just within the last six months, Aon, a global company that provided governance advice to the System, quit. McLagan, a company providing compensation advice and research to STRS for over 20 years, also guit in July. Two board members have resigned. In perhaps the biggest blow to the system, the Cincinnati Federation of Teachers, an affiliate it was announced at the end of September that three top leaders were leaving. Executive Director Bill Neville, who nearly a year ago was anonymously accused of misconduct then cleared of the accusations after an independent investigation ordered by the Attorney General, signed a \$1.65 million separation agreement. Acting Executive Director and Chief Financial Officer Lynn Hoover is retiring December 1 and Matt Worley, Deputy Director—Investments and Executive Chief Investment Officer is leaving March 31.

Board member Julie Sellers provided all that was needed for the chaos to continue when she made a motion at the September 20th board meeting for a vote of no confidence in **all senior management** and investment staff. Her motion was quickly seconded by fellow "reformer" Michelle Flanigan who joined the Board a couple months ago. The basis for Sellers' motion is her displeasure over a 14-page memo sent by a member or members of the STRS staff to the Governor alleging misconduct by two of her fellow reformers...Rudy Fichtenbaum

Wade Steen. Both men allegedly promoted investing \$65 billion of STRS assets in QED, a firm whose legitimacy has been openly challenged by more than one source. Some Board members questioned the intent of the motion, including Pat Davidson who is considered by some a "reformer" but who was not wearing the reformer hat in this case: "I guess I just want to get clarification on what the no confidence vote is again, because what I heard you say before is a little different than what we just said now..." Sellers replied, "As we are moving forward that we are making sure that we have all of the information to make the decisions that, uh, we need in order to make the decisions that, uh, we will have to have you know making those decisions." (Good luck figuring that one out!) Fortunately, her motion failed. (It's interesting to note that Ms. Sellers gave no thought to offering a no confidence motion aimed at the author of the anonymous complaint against Mr. Neville even after he was exonerated.)

Sellers has served several years as president of union of the Ohio Federation of Teachers. Insofar as the number of STRS employees who were involved in producing the memo is unknown, her motion's inclusion of "all senior management and investment staff" conflicts with what certainly had to be part of her training and practice as a K-8 certificated teacher, i.e., you don't punish the whole class for the misdeeds of one or a few. Beyond that, there is a legitimate question about whether sending the memo to the Governor can even be considered a misdeed. A clear case can be made that whoever sent the memo was "whistleblowing" and is protected by the U.S. Department of Labor's Whistleblower protection laws. Those laws prohibit an employer from retaliating against an individual for reporting any of a wide range of issues, including fraud and financial issues. Retaliation is defined as an employer taking adverse action against an employee for engaging in protected activity. The Labor Department defines "adverse action" as any action that "would dissuade a reasonable employee from raising a concern about a

possible violation or engaging in other related protected activity." Apparently, Sellers does not recognize the similarities between an STRS employee (or employees) raising a concern about his (her, their) employer (the STRS Board) under the Whistleblower Act and her own union members reporting a possible district violation, contractual or not, to her as union president. If the Cincinnati school board took adverse actions against a teacher for going to the union, it would be subject to a very legitimate unfair labor practice charge by the union.

After the no confidence vote was rejected, the board members recessed into executive session. When they reconvened, Lynn Hoover set aside a scheduled presentation to express her frustration and disappointment with the no confidence motion even though it failed. She pointed out to the board how harmful and counter-productive the act was in terms of the System's effort to find legislators willing to sponsor a bill to increase the employer contribution. She expressed how discouraged staff has become as a result of the constant criticism by reform Board members. She challenged members to tell staff what they expected of leadership that leadership isn't already doing. Only Wade Steen came up with an example and that was for staff to investigate selling the STRS building. Steen conceded that leadership had in fact been working on that assignment, but that they needed to move faster.

The board now must find replacements for positions that are vacant or will soon be vacant. Hopefully, the process will not be chaotic and the new leadership selections will not drive more key personnel to leave the System.


# U.S. House Will Vote on WEP, GPO Repeal

The U.S. House of Representatives will vote whether or not to repeal of the Social Security Windfall Elimination Provision (WEP) and the

Windfall Elimination Provision (WEP) and the Government Pension Offset (GPO). Co-sponsors Abigail Spanberger (D-Virginia) and Garret Graves (R-Louisiana) collected 327 co-sponsor signatures in support of repeal. The House vote will take place as the result of a discharge petition reaching the 218 signatures (47 R's and 171 D's) necessary to force the vote. A discharge petition is a strategy used to advance a bill to a vote of the full House without a report from the relevant committee.

WEP is a social security rule using a formula to reduce benefits for individuals who held jobs under social security but also earned a public pension. GPO likewise reduces spousal benefits for retired public pension employees. Estimates are that WEP affects two million and GPO 800,000 retirees.

In spite of unprecedented bi-partisan support, if the House votes to repeal WEP and GPO, the legislation faces a battle on the Senate side, even though the Senate version of the bill has 62 bipartisan cosponsors. Repeal would result in an average \$7,300 annual increase in benefits for those affected beginning in *December, 2023*. At this time, the two greatest obstacles to passage of the bill are the additional cost which would be added to the unresolved Social Security program funding for 2025 and the short amount of time remaining between now and the end of the current session of Congress. *Bill Seigferth, Legislation Chair*

### **ORTA Donations Under Investigation?**

The Ohio Ethics Commission will not disclose whether or not ORTA is under investigation for paying over \$100,000 in legal fees for STRS board members **Wade Steen** and **Rudy Fichtenbaum**.

**Laura Bischoff** of the USA Today Network recently reported that the "(Ethics) Commission has said that public officials can't accept contributions to pay for their legal fees from any 'prohibited' sources—those that have interests before the public agency." The Ethics Commission Director said that whether ORTA is considered a "prohibited source" would have to be determined via investigation. A Case Western Reserve law professor said the ORTA contributions raise a "red flag." "If you have certain benefits being paid to an individual, who's supposed to represent a complete group of people, from a segment of that group of people, it creates concerns that there are going to be policies that favor them."

It has been reported that ORTA did not seek an opinion from the Ethics Commission before paying the legal fees. In recent correspondence with ORTA liaisons, Robin Rayfield said that ORTA instead did receive a lawyer's opinion that the legal fee payments comply with the law. The opinion did not come from an ORTA attorney but, incredibly, from one who is on the receiving end of the payments, Wade Steen's attorney! Bill Siegferth - Legislatve Chair

### FROM the SCRTA ARCHIVES: 25 Years Ago

Have you invited a retiree to attend a meeting lately? Recently the SCRTA Marketing team has worked diligently to get the word out about our Association. Lately we have had fifty to sixty-some members in attendance at the meetings. Our archives show much greater numbers for the year 1999. Back then the board members were able to mail hundreds of letters and newsletters to new retirees over the summer inviting them to join SCRTA. Because of privacy rights, gone are the days when two board members were able to acquire contact information for new retirees from all the Summit County schools.

In the October 1999 newsletter, SCRTA President Blin Scatterday began his "President's Message" with these words: "It was really exciting at the September luncheon as we added forty (40) NEW MEMBERS! I hope this is just the beginning of a membership surge for **1999**. You can help by calling a retired friend and inviting them to attend the luncheon with you. "Here are a few other details gathered from the year's management board minutes:

A board member asked why our chapter did not offer a scholarship. The reason given was it was not financially feasible at that time. (This did get the ball rolling. More on this another day.)

There was a request for \$45 from the Honor Fund. The fund was established in 1983 in memory of teachers to financially aid retired teachers with medical expenses. Contributions to the memorial fund were made by members - sometimes through their estates – and from a portion of life membership dues. It was a separate 501(c) (3) organization with its own board of several retirees. (Later after a long time passed with no requests, the fund was dissolved.)

The Fall trip for the year was to see a few highlights in Cleveland: a guided tour of the Plain Dealer, a visit to the Eastside Market, Luncheon at Sokolowski's Inn in Tremont, a guided tour of the Civil War exhibit at the Western Reserve Historical Society, and other stops if time permitted.

Meetings were held at the Tangier Restaurant. After the buffet lunch, there was musical entertainment followed by a speaker, some of whom were a French horn trio from Firestone High School and speaker Mrs. Laura Ofobike, a writer from the Akron Beacon Journal. (It was noted later that she donated her honorarium to the Ronald McDonald House.) At another meeting, a flute player and a clarinet player from Norton High School played classical pieces followed by the Marketing Director of the Akron/Summit Public Library who spoke about the plans for expansion and progress of the proposed cultural district. At a later luncheon, the Jazz Band from Miller South School played several numbers.

Attendance at luncheon meetings that year ranged from 195 to 270. Membership was reported to be 851 with 503 life members, 496 ORTA members and 285 prospective members.

Announcements at luncheon meetings always included requests from area organizations for volunteers. Several members attended and reported back on out-of-town ORTA district meetings.

Among several legislative reports were updates about Ohio's HB199, proposed by insurance companies, that would provide an alternative to the state's pension plans. SCRTA's legislative chairperson wrote to AARP indicating our displeasure with their stand in supporting nationwide mandatory Social Security for teachers. If either of those proposals had passed, it would have greatly hurt Ohio's retirees.

The Community Participation committee made many reports on donations SCRTA made to Ronald McDonald House and listed numerous items donated month after month.

The archives not only show the many activities of SCRTA but also the connectedness of the people to each other and to the Summit County community. *Rebecca Moore, Administrative Assistant*
