SCRTA Community Service Projects: Ronald McDonald House Akron and Shelter Care



Thanks so much to the many SCRTA members who saved and donated pull tabs for the Ronald McDonald House. Those tabs are recycled for cash, which is then used to give families of children who are hospitalized a few extras at this critical time in their lives. The extras include birthday gifts, trips to the hair salon or anniversary dinners, in other words, a little normalcy when little else seems normal.

Elaine Jarvis graciously and diligently kept the names of all of you who contributed last year. We put those names in a hat and drew two (2) winners, Jeanette Scott and Mary Lou Swartz, who each got a \$25 gas or grocery gift card at the November luncheon. Congratulations to Jeanette and Mary Lou and many thanks to ALL who participated!

We continue to need your help. Please keep saving the tabs from all the beverage, soup, pet food, and other canned goods that you may use. It takes about 1000 tabs to equal a pound of aluminum, and every tab helps! *We will have a Community Projects table at each luncheon where you can drop off the tabs you have collected. If you prefer, you can keep collecting and bring a full baggie, box or other container of tabs. Although we will no longer keep track of who is bringing tabs for an end of year drawing, there will be a basket with candy (one piece per meeting, please) to thank you for your dedication to this and our other projects.* We will also continue to accept donations of toiletries, paper products, individually wrapped snacks, and juice boxes at luncheons for Ronald McDonald House. Watch for some new ideas regarding donations to RMH.

Another organization that we have elected to assist is the Safe Landing Youth Shelter (Shelter Care). This program provides crisis and emergency services to children aged 11-17. Safe Landing provides short term residential care, with the length of a child's stay dependent on circumstance and need. Up to 12 children can be housed at any one time. Shelter Care's winter needs include bottled water, individually wrapped snacks, hand warmers, dryer sheets, Lysol disinfectant wipes and sprays, laundry detergent, disposable silverware, and paper plates. They can always use shampoo and conditioner, body wash and deodorant and request that these items be full size. These items can be brought to SCRTA luncheon meetings, and they will be delivered to Shelter Care within a few days, if not the same day.

If you bring more than 5 donation items to the luncheon for either RMH or Shelter Care or if you bring a container of tabs, you will be given an additional ticket for the door prize drawing. Door prizes are currently gas and/or grocery gift cards. Thank you for your help and generosity in assisting these worthy causes!

President's Message



Bill Siegferth Increasing Employer Contribution Rate: A Big Challenge

STRS staff is having on-going discussions with legislators, but at this time there has been no public statement or announcement regarding bill sponsorship. We don't expect any serious movement in that respect until negotiations over the state budget are completed. At that point, we expect finding sponsors, particularly bi-partisan sponsors, will be a real challenge.

Finally, the Ohio School Boards Association (OSBA) is not warm to the idea of employer contribution increases. STRS began discussing the idea in late 2023. At the time, a news source's coverage of the story included the thoughts of the OSBA's chief executive, Kathy McFarland. McFarland commented that her organization "would oppose any increase in the employer contribution rate." We do not know if OSBA's position has changed, but we're guessing it has not.

In summary, passage of legislation authorizing an increase in the employer contribution rate will clearly be a challenge. It will be less of a challenge if the new budget includes school funding increases and/or if the Vouchers Hurt Ohio lawsuit, challenging the constitutionality of the voucher program, prevails in Franklin County Common Pleas Court. That case was scheduled to go to trial in November of 2024, but delayed by the judge until 2025. In all likelihood, the issue will make its way to the Ohio Supreme Court regardless of its fate in Franklin County, making it unlikely that a ruling will be handed down, favorable or unfavorable to Vouchers Hurt Ohio's arguments, in time to impact STRS efforts over the short term to increase employer contribution rates.

Retirees can play an important role in persuading the legislature to vote for an STRS proposal to increase the employer contribution rate. As a member of the coalition, SCRTA will ask each member to become involved in the manner requested and suggested by those leading the campaign.

The Latest on WEP, GPO

The recent passage of the Social Security Fairness Act will result in the Social Security Administration (SSA) computing benefit adjustments for over 3 million people. The repeal is effective with the January 2024 benefit, and applies only to persons who have earned a public pension and a social security benefit. According to the SSA, computing retroactive adjustments is very complex and their early analysis is that much of the work

must be done manually and on an individual case-by-case basis. While work has begun processing adjustments, SSA is cautioning that "it could take more than one year to adjust benefits and pay all retroactive benefits." Calling the SSA for information at this time will result in long hold times. Regularly updated information can be found on line at <u>https://www.ssa.gov/benefits/retirement/social-security-fairness-act.html</u>.

SSA is cautioning beneficiaries that "bad actors" or "scam artists" may try to take advantage of the new law. The agency states that "SSA will never ask or require a person to pay either for assistance or to have their benefits started, increased or paid retroactively." They recommend that beneficiaries hang up on phone calls and not to click or respond to anyone offering to increase or expedite benefits through on line communications. Prior to each shopping trip, Betty telephoned the house resident manager for the Wish List, and the two women agreed on several items to be purchased. SCRTA supplied the kitchen, bedrooms, bathrooms, housekeeping tools, and even the patio. There are no specific records from 1986 when the project began, but there are itemized lists from 1987 to 2003. Occasionally SCRTA donated money designated for something such as \$500 in 1994 for bedspreads. Many items were "repeat In the Winter 2000 issue of "Care Cables: Akron's buys" over the years when things wore out or were lost such as dozens of bath towel sets with extra washcloths, thanked for being one of their long-time donors of money, sheet sets (replaced many times), mattress covers, RMH depended on community pillows and cases, bathmats, sponge mops, and more than 12 dozen drinking glasses over time. They bought drapes, budget. Records filed in the archives of donations from 5-quart pots, tea kettles, electric knives, Tupperware, kitchen towels, plastic clothes hangers, many sets of dishes, toasters, coffee muqs, food processors, electric can openers, electric blankets, hand food mixers, toilet paper, a gross of toothbrushes, dish detergent, bars of soap (100 at a time), a heavy-duty hand truck, a VCR, video tapes, and watermelons and ice cream for the 4th of July. Kitchen equipment for bread baking was provided as were five folding chairs, two high-back chairs, one lounge chair and two tables for the patio. Heavy-duty sweepers were donated in 1992 and 1996. It appears the 48 place settings of flatware did not have to be replaced.
